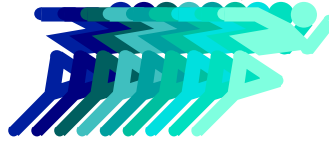

RULES & REGULATIONS

1. NO DOGS OR PETS ALLOWED IN PARK !

2. Picnic tables or other items are not to be removed from the pavilion.
3. Groups are to utilize only the pavilion to which they have been assigned.
4. Groups who have reserved and been assigned a pavilion will be given preference over groups who do not have reservations.
5. Pocono Township groups/organizations will be given preference over non-township groups/organizations.
6. Trash and litter are to be placed in proper containers.
7. Open fires are not permitted. (Grills must be extinguished before leaving.)
8. Park officials reserve the right to reassign groups to larger/smaller pavilions if the number of attendees dose not equal the number on the application.
9. Fields and play areas are to be shared.
10. Groups or individual requesting permission are responsible for and damage to the park or equipment by members of that group.
11. No Confetti or Glitter allowed in pavilions.

13. Money Return Policy: Must cancel 30 prior to reserved date or forfeit money.

15. Failure to comply with all park rules and regulations could result in banishment from the park and/or legal action and forfeit of the rental fee for the pavilion.
